



## ORDINANCE

### CREATING A NO PARKING ZONE ON BOTH SIDES OF AETNA COURT

### *CITY OF NASHUA*

*In the year Two Thousand and Eight*

*The City of Nashua ordains* that Chapter 320 “Vehicles and Traffic”, Article XII “Parking, Stopping and Standing”, Section 320-69 “No parking on certain streets”, of the Nashua Revised Ordinances, as amended, hereby be further amended by adding the following new underlined language in the appropriate alphabetical order:

**“§ 320-69. No parking on certain streets.**

No parking whatsoever shall be permitted on the following streets, except as provided by law:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>

<u>Aetna Court</u>	<u>Both</u>	<u>Entire length</u> ”

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall become effective at the time of removal or installation of the necessary sign(s).
