



ORDINANCE

REGARDING THE INTRODUCTION OF THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AND HOME FUNDS RESOLUTION

CITY OF NASHUA

In the Year Two Thousand and Nine

The City of Nashua ordains that Part I “Administrative Legislation,” Chapter 5 “Administration of Government,” Part 2 “Board of Aldermen”, Article III “Rules and Order of Business”, Section 5-19 “Necessary procedure for passage” of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the following new underlined subsection F, and relettering the existing subsections appropriately:

“5-19. Necessary procedure for passage.

...

- E. The sponsor(s) shall authorize the introduction of ordinances and resolutions no later than 5:00 p.m. on the Wednesday prior to the Board’s regular meetings. A member may be an endorser only if the member signs the legislation. Additional endorsements can be made upon first reading of the legislation, but not subsequent to that time.
- F. Any resolution to apply for, and/or accept and appropriate Community Development Block Grant (CDBG) and/or HOME funds shall not be introduced prior to any application deadlines for such funds.”

All ordinances or parts of ordinances inconsistent herewith are hereby repealed. This ordinance shall take effect upon its passage.
