**AUTHORIZING FREE HOLIDAY PARKING AT METERS IN ZONES I, II AND III
FROM DECEMBER 10, 2014 THROUGH DECEMBER 26, 2014**

CITY OF NASHUA

In the Year Two Thousand and Fourteen

The City of Nashua ordains that Part II “General Legislation”, Chapter 320 “Vehicles and Traffic”, Article XI “Parking Meters”, Section 320-47 “Parking meter and reserved space fees; permits; meter bags”, subsection A of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the following new underlined language:

“§ 320-47. Parking meter and reserved space fees; permits; meter bags.

- A. The parking fee for all . . .
- (1) ...
 - (2) ...
 - (3) ...

The parking fees in (1) – (3) above shall not be enforced from December 10, 2014 through December 26, 2014.”

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall become effective upon final passage.



FROM DECEMBER 10, 2014 THROUGH DECEMBER 26, 2014**

In the Year Two Thousand and Fourteen

The City of Nashua ordains that Part II “General Legislation”, Chapter 320 “Vehicles and Traffic”, Article XI “Parking Meters”, Section 320-47 “Parking meter and reserved space fees; permits; meter bags”, subsection A of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the following new underlined language:

The parking fees in (3) above, which includes the metered spaces in the Elm Street and High Street parking garages, shall not be enforced from December 10, 2014 through December 26, 2014.”

The revenue loss and additional costs associated with Amended O-14-008 is estimated to be \$8,600.
