RESOLVED by the Board of Aldermen of the City of Nashua that the City of Nashua and the Nashua Police Department are authorized to accept and appropriate the sum of \$40,175 obtained from the State of New Hampshire into Special Revenue Account 331-6262 "NH Drug Task Force 2009" and to authorize the transfer of \$15,000 from Account 591-86607 "Contingency-Police Grants" into said special revenue account for the purpose of law enforcement for the period of 7/1/08 - 6/30/09.

FISCAL NOTE:

Fiscal impact is a \$40,175 grant to the city to be used for a particular purpose. There is no required City match, however to fund the project at the same level as funded in previous years a transfer of \$15,000 is requested from Contingency-Police Grants budgeted for this purpose.

ANALYSIS


This resolution authorizes the City of Nashua and the Nashua Police Department to accept and appropriate \$40,175 obtained from the State of New Hampshire into Special Revenue Account 331-6262 "NH Drug Task Force 2009" for the purpose of law enforcement for the period of 7/1/08 – 6/30/09. \$15,000 will be transferred from Account 591-86607 "Contingency – Police Grants" (budgeted for this purpose) into the special revenue account for funding purposes.

Charter Sec. 53 permits the Board of Aldermen to transfer any unencumbered appropriation balance or any portion thereof from one department, fund or agency to another.

NRO § 5-130, H provides that "when proposed legislation to transfer or reappropriate a particular appropriation or portion thereof has had its first reading, such funds shall not be expended or transferred while the legislation is pending".


