RESOLVED by the Board of Aldermen of the City of Nashua that the City of Nashua and the Office of Economic Development are authorized to accept and appropriate funds in the amount of \$20,000 from the State of New Hampshire Department of Resources and Economic Development into Special Revenue Account #373-6800 "Telecom Growth Programs Matching Grant" for the purpose of research and development of a technology park in Nashua. The funding will be for identifying the needs of existing and future businesses, researching institutional capacity and proven models, outreach to academic institutions, development of alternative scenarios, and marketing to prospective businesses. These funds are available through December 31, 2008.


