APPROVING A FIRST AMENDMENT TO A CONTRACT FOR SERVICES WITH THE
HUMANE SOCIETY FOR GREATER NASHUA CORPORATION

RESOLVED by the Board of Aldermen of the City of Nashua that the attached First Amendment to Contract for Services with the Humane Society for Greater Nashua Corporation to provide for an increased monthly payment from the City to the Humane Society from July 1, 2009 through June 30, 2011 to cover the Society's increased costs in providing services to the City is hereby approved.

FIRST AMENDMENT TO CONTRACT FOR SERVICES

This First Amendment to a Contract for Services is entered into this _____ day of _____, 2009 by and between **CITY OF NASHUA**, a municipality in the State of New Hampshire (hereinafter referred to as "City"), and the **Humane Society for Greater Nashua Corporation**, (hereinafter referred to as "Society") whose address is 24 Ferry Road, Nashua, NH 03064.

WHEREAS, the City and the Society entered into a Contract for Services, covering the period of time from July 1, 2006 through June 30, 2011, whereby the parties agreed to terms for services to be performed relative to animal care and shelter; and

WHEREAS, Section 15 of the Contract for Services provides in part, "[t]he City shall pay the Society per month for goods and services to be provided by the Society to the City pursuant to this Agreement the amount of \$7,756.83 per month commencing July 1, 2007 through the remainder of the contract June 30, 2011"; and

WHEREAS, the City processed a payment on or about December 15, 2008, paying the Society an additional \$6,000 to cover the Society's increased costs in providing services to the City; and

WHEREAS, the parties wish to amend their Contract for Services to provide for an increased monthly payment from the City to the Society for the period between July 1, 2009 through June 30, 2011 to cover the Society's increased costs in providing services to the City.

NOW THEREFORE, for good and valuable consideration, receipt of which is acknowledged, the parties covenant and agree as follows:

1. The second sentence in section 15 of the parties' Contract for Services shall be replaced with the following sentence: "The City shall pay to the Society per month for goods and services to be provided by the Society to the City pursuant to this Agreement the amount of \$7,756.83 per month commencing July 1, 2007 through June 30, 2009, and the amount of \$8,256.83 per month commencing July 1, 2009 through the remainder of the contract, June 30, 2011."

ANALYSIS



The agreement provides for payments in FY10 and FY11 for which funds have not yet been appropriated.


