**RESOLVED** by the Board of Aldermen of the City of Nashua that the City of Nashua and the Nashua Police Department are authorized to accept and appropriate the sum of \$290,929 from the United States Department of Justice into Special Revenue Account #331-6271 "Justice Assistance Grant 2009 (Multi-Jurisdictional)" for the purpose of allowing Nashua and other government agencies to purchase equipment and/or pay overtime. No matching funds are required for this grant. Upon receipt of proof of purchase, Nashua will reimburse the below agencies for eligible items through the warrant process. The total reimbursements shall not exceed the amounts listed for each respective agency.


**ANALYSIS**


