



RESOLUTION

EXTENDING CONGRATULATIONS TO THE NASHUA HIGH SCHOOL NORTH BOYS' AND GIRLS' SWIMMING AND DIVING TEAMS

In the Year Two Thousand and Eleven

RESOLVED by the Board of Aldermen of the City of Nashua that congratulations from Mayor Donnalee Lozeau and the Board of Aldermen are hereby extended to the Nashua High School North Boys' and Girls' Swimming and Diving Teams.

WHEREAS, in the past four years, Nashua High School North has had twelve individual State Champions, seven Relay State Champions and two New England Champions, including the following 2011 State Champions: Jennifer French, 1st place in the 50 yard freestyle; Nathan Garner, two time State Champion in the 500 yard freestyle; and, Taylor Martell, two time State Champion in the 100 yard breaststroke. Taylor Martell is also the 2011 New England Champion in the 100 yard breaststroke.

WHEREAS, the 2010 swimming and diving program was voted as the number one Division 1 swimming and diving program in the area of sportsmanship.

WHEREAS, the Nashua High School North Boys' Swimming and Diving Team took home the runner up plaque at the Division 1 State Championship in 2009, 2010 and 2011. In those three years the boys had only two losses in the regular season.

WHEREAS, the Nashua High School North Girls' Swimming and Diving Team were the Division 1 State Champions in 2008, runners up in 2009 and 2010 and State Champions again in 2011. The girls have not lost a regular season meet in five seasons.

WHEREAS, seventy-five percent of the teams' members are on the honor roll with twenty-six percent consisting of the "all A's" honor.

NOW THEREFORE, Mayor Donnalee Lozeau and the Board of Aldermen on behalf of the citizens of the City of Nashua, extended their congratulations to the teams, their families and their coaches and are very proud of the Nashua High School North Boys' and Girls' Swimming and Diving Teams, who have "a program of excellence".

Your enthusiasm, hard work, dedication, sportsmanship, academia and accomplishments bring recognition and pride to the City of Nashua. We thank you for your spirit.
