**WHEREAS**, Kathy Richardson Bolton has resigned her post on the Child Care Advisory Commission after 21 years of service with the City of Nashua, New Hampshire; and

**WHEREAS**, Kathy Richardson Bolton chaired the Child Care Advisory Commission for the 1991-1993 and 2002-2005 terms and has been an outstanding chairperson and leader by motivating the membership of the Child Care Advisory Commission with annual events such as the Early Childhood Fairs, "Stand For Children" ceremonies, the Mayoral Proclamation Ceremonies for the Week of the Young Child, preschool open house events and the Child Care/Family-Friendly Employer Award Programs; and

**WHEREAS**, Kathy Richardson Bolton served and participated on the Community Relations Committee, the Nominating Committee, the Long Range Planning Committee, the Bylaws Committee, and the annual "Touch-A-Truck" event, which has resulted in over \$10,000 in donations to date; and

**WHEREAS**, Kathy Richardson Bolton has supported the work of the Child Care Services Office and its mission to assist families with the child care needs and has been instrumental in engaging the Mayors and Aldermen throughout her 21 years with the Commission in the discussion about work/family issues for our city's young families; and

**WHEREAS**, Kathy Richardson Bolton, while witnessing the ebb and flow of issues for the families, care providers and children in Nashua, has never waived in her commitment and support for safe, developmentally-appropriate environments for Nashua's children and chaired the first Community Needs Assessment for Child Care in Nashua in 1992 which resulted in concrete data about the gaps in services, needs of families and barriers to safe, quality, affordable care; and

**WHEREAS**, Kathy Richardson Bolton strengthened the community by dedicating her time and energy to Nashua's early childhood programs such as the "Adopt-A-School" Program and her work on the Legislative Committee of the Child Care Advisory Commission, which has been proactive in heightening the awareness of local and state legislators to the issues of early childhood care and education; and
