



## RESOLUTION

HONORING PASTOR ROBERT “ODIE” ODIERNA

**RESOLVED** by the Board of Aldermen of the City of Nashua that

**WHEREAS**, Pastor Robert “Odie” Odierna has resigned his position on the Child Care Advisory Commission after 11 years of service with the City of Nashua, New Hampshire; and

**WHEREAS**, Pastor Odierna served on various committees while on the Commission including the Nominating Committee, the annual “Touch-A-Truck” event which has resulted in over \$10,000 in donations to date, the Week of the Young Child Planning Committee, the Long Range Planning Committee, the Center and Provider Support Committee, and leading the Child Care Professional of the Year Award Program; and

**WHEREAS**, Pastor Odierna chaired the “Adopt-A-Center” Committee which was key in developing bridges between the city’s child care providers and the government as well as chairing the Public Engagement Committee building relationships with the media to advance the public’s awareness of early childhood issues; and

**WHEREAS**, Pastor Odierna presented the Brain Research Project of 2001 to local businesses and non-profits resulting in the education of professionals about the importance of quality care of children from birth to three years and he has supported early childhood care and education programs with strong advocacy for those children in need of affordable care and scholarship assistance; and

**WHEREAS**, Pastor Odierna represented faith-based organizations and their interest in the work/family issues of families in Nashua and the region throughout his tenure; and

**WHEREAS**, Pastor Odierna was awarded the Chamber of Commerce’s Eminence Award in 2006 for his volunteer efforts; and

**WHEREAS**, Pastor Odierna and has been instrumental in partnering with the Commission membership to provide financial education workshops for consumers at Nashua Pastoral Care which resulted in heightened awareness of consumers’ capacity to plan for their families’ needs and through his work with the Nashua Pastoral Care Center in 2010, a partnership with Early Head Start resulted in the provision of affordable child care for children from birth to three years providing available care options for families in need of scholarship support.

**NOW THEREFORE**, Mayor Donnalee Lozeau and the Board of Aldermen, on behalf of the citizens of Nashua, express their thanks and appreciation to Pastor Odierna for his many years of dedication to the City of Nashua.
