



## **RESOLUTION**

**RESOLVED** by the Board of Aldermen of the City of Nashua that the purpose of the remaining unexpended bond proceeds previously reserved and designated under Resolution 10-27, and amended by Resolution 11-163, be changed as follows:

The original purpose from R-10-27 and R-11-163 was for various listed school improvements. The new purpose will be for \$1,900,000 to be used for Charlotte Avenue Elementary School HVAC improvements, with a useful life of 20 years.

**ANALYSIS**


