



## **RESOLUTION**

### **NAMING THE ROBY PARK FIELDS THE "JEFF MORIN FIELDS AT ROBY PARK"**

#### ***CITY OF NASHUA***

*In the Year Two Thousand and Twelve*

**RESOLVED** by the Board of Aldermen of the City of Nashua that the Roby Park fields shall be named the "Jeff Morin Fields at Roby Park". This is to honor the late Jeff Morin, who was involved with youth sports and was a volunteer in the Special Olympics Program.

Jeffrey Thomas Morin was a native resident of Nashua having grown up in the south end of Nashua spending a lot of time playing at Roby Park as a child. He attended Bicentennial Elementary School, Fairgrounds Junior High School, and Nashua High School. He was valedictorian of his class at Fairgrounds Junior High School. While a sophomore in the top 1% of his class at Nashua High School. Jeff's life was tragically cut short in a motor vehicle accident at age 15.

In 1995 the Morin family established the Jeff Morin Memorial Scholarship Fund which began awarding scholarships in 1997 and has awarded over \$200,000 in scholarships to Nashua South and North graduating seniors since its inception.

Jeff was a member of the National Honor Society, the Nashua High School golf and ski teams, the Christian Youth Organization, the All-Star Basketball Team and the All-Star City League.

The Morin Family has generously gifted a monetary memorial fund to the NH Charitable Foundation to be used by the City of Nashua for park improvements, programming, and scholarships. A future Special Olympics event is being planned for the fall of 2012 in Jeff's honor.
