FURTHERMORE, BE IT RESOLVED that the members of the jury for the Nashua Millyard / Broad Street Parkway design competition shall be invited to participate as members of this competition jury, if they so choose, and that the President of the Board of Aldermen shall appoint two additional members to the competition jury who are Nashua residents, live near Greeley Park and have music and/or sound experience; and the jury shall be responsible for soliciting, evaluating and rating the proposals, which shall be presented to the Board of Aldermen within one month after the jury has rated the submissions; and

FURTHERMORE, BE IT RESOLVED that submissions for the competition will become the property of the city; will be advisory only; and the City shall have no obligation to construct any component of the winning entry or entries.
