

ORDINANCE

RELATIVE TO THE DISPOSITION OF RESOLUTIONS TO APPROVE THE COST ITEMS OF COLLECTIVE BARGAINING AGREEMENTS

CITY OF NASHUA

In the Year Two Thousand and Nine

The City of Nashua ordains that Part 1 “Administrative Legislation”; Chapter 5 “Administration of Government”, Part 2 “Board of Aldermen”; Article III “Rules and Order of Business”, Section 5-19 “Necessary procedure for passage” of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the new underlined language as follows and re-lettering existing subsection “I” as new subsection “J”:

“§ 5-19. Necessary procedure for passage.

...

I. No resolution to approve the cost items of a collective bargaining agreement may be disposed of under a suspension of the rules if there is time for the board of aldermen to hold a special meeting within thirty days of the first reading of the resolution. This subsection may not be suspended under § 5-23.”

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

This ordinance shall take effect following its passage.
