**RESOLVED** by the Board of Aldermen of the City of Nashua that congratulations from Mayor Donnalee Lozeau and the Board of Aldermen are hereby extended to Carolyn Walley for having earned the Girl Scout Gold Award.

The Girl Scout Gold Award is the highest award in Girl Scouting. It symbolizes outstanding accomplishments in the areas of leadership, community service, career planning and personal development. To earn the award, a young woman must plan and implement a large-scale community service project. It is a multi-year process that challenges each Girl Scout to embark on a project that will make a real lasting impact upon society. The award is even more prestigious considering only 5.4% of eligible Girl Scouts nationally complete a project of stature to earn it. Recipients of the Gold Award who enlist in any branch of the U.S. Armed Forces are automatically raised one rank in recognition of their achievements.

The service project chosen included a two-part program on college safety which was implemented at Nashua High School South to empower all area high school students this year and for years to come. Part 1 is the College Safety Workshop at which heads of security from area colleges address students regarding ways to stay safe while on campus and Part 2 a nationwide women's self-defense program RAD (Rape, Aggression, Defense) at which Nashua Police Department representatives teach participants moves to protect themselves in an attack and also ways to avoid an attack. The project goes through a vigorous review process by the Girl Scout Gold Award Review Committee prior to and at the completion of the project. Also congratulated are the Project Advisor, Meg Tabacsko, and Carolyn's Troop Leader, Kathy Owens, each of whom provided indispensable encouragement and advice.

Girl Scout Gold Award recipients are well on their way to the leadership positions in society for the future of our city, state, nation, and global community. They demonstrate the hard work, determination, and tenacity necessary to achieve this prestigious goal. Carolyn's accomplishment brings pride to the City of Nashua. We wish you the best.
